

ACKNOWLEDGEMENTS

This research was made while I was in Brazil, first as USAID-Vanderbilt visiting professor of economics at Instituto de Pesquisas Econômicas (IPE), University of São Paulo (1966-1968), then (overlapping) as economic advisor to the Ministry of Finance (1967-1969), and subsequantly as economic advisor to Comissão Interestadual da Bacia Paran-Uruguai (better known by its short name "Bacia") (1968-69). In the development of this study, I received help from several agencies and individuals. Although it is not possible, in this brief note, to acknowledge gratitude to all of these, mention must be made of the following agencies and individuals. At first, about the agencies and institutions.

The research of Essay No. 1 was financed entirely by Instituto de Pesquisa Econômica Aplicada (IPEA), Ministry of Planning and General Coordination, through a research grant channled through ANPES, São Paulo, during the year 1968-69. Preliminary ground in this study was also broken in 1966-67 when I was still at IPE, but the study was completely restructured and redone in 1968-69 under the IPEA research grant. The actual research was carried out at Bacia where, in my capacity as the economic advisor to the Ist Vice President, I was provided liberal research and secretarial facilities, both for for the present research and the agricultural research project which was being carried out at Bacia under my supervision. The Ministry of Finance, which was especially interested in this research and the Chair of Econometrics, University of São Paulo also provided certain research facilities, including computer service. Thanks, therefore, are due, first, to IPEA and, then, to ANPES, Bacia, USAID, the Ministry of Finance, and the Chair of Econometrics, University of São Paulo.

The research of Essay No. 2 was completed during 1967-68 when, under an arrangement of the Ministry of Finance and the Ministry of Planning and General Coordination, I was provided with two research assistants, office space, and other research and secretarial facilities at IPEA. Although the major calculation and data processing work was done at IPEA, the study was written while I was still at IPE. Thanks for this essay, therefore, go to IPEA, IPE; USAID, and the Ministry of Finance.

The research of Essay No. 3 was done in my individual capacity during the summer vacations. For this, I make acknowledgement to USAID, which gave me an opportunity to come to Brazil, without which no research on Brazil could have been undertaken.

Acknowledgements are also made to Fundação Getúlio Vargas for letting some of their as-yet unpublished data, such as those on rural family budgets, be used by me; the Graduate Center for Latin American Studies, Vanderbilt University, for contributing a part of the secretarial costs while I was a visiting professor at IPE; and Graduate Program in Economic Development, Vanderbilt University, for sundry assistance.

Coming to individuals, my especial acknowledgement goes to Antonio Delfim Netto, the Finance Minister of Brazil, for giving intellectual stimulation, constant encouragement, and either giving or making arrangements for liberal research facilities. In him I found an economist who encouraged quantitative research based on economic analysis, which I had learnt at the University of Chicago. Without his personal interest and help, I would not have had access to the research fucilities provided me, among others, by IPEA and Bacia. I benefitted most from periodical discussions with Affonso Celso Pastore and Carlos Antonio Rocca--my closest colleagues in teaching and research both at IPE, University of São Paulo and the Ministry of Finance.
