





What is the IPC-IG?

The International Policy Centre for Inclusive Growth (IPC-IG) is a global forum on innovative development policies, and its work reflects its mission of promoting policy dialogue and facilitating learning between developing countries on development policies that contribute to inclusive growth, poverty and inequality reduction and human development.

Guided by a partnership agreement between the Government of Brazil and the United Nations Development Programme (UNDP), with the support of the Brazilian Cooperation Agency (ABC), linked to the Ministry of Foreign Affairs, the IPC-IG was founded in 2002 and began its activities in 2004. Since then, the Centre has been providing services and tools to strengthen the institutional capacities of countries to design, monitor and evaluate development policies. Alongside its partners, policymakers and experts, the IPC-IG develops solutions to strengthen both human and institutional capacities and resources.

The innovative approaches used by the IPC-IG are based on three pillars:

- Knowledge production: carrying out research and studies, such as policy analysis and evaluations:
- Knowledge-sharing: gathering knowledge and facilitating the exchange of innovative experiences and initiatives among countries; and
- Capacity-strengthening & advisory services: advising, providing and facilitating the collaborative construction of capacity-strengthening activities and flows of knowledge across countries.

The IPC-IG's 2021 Activity Report


The IPC-IG is pleased to release its 2021 Activity Report, presenting the Centre's projects, activities, achievements, and results from 1 January to 31 December 2021. During this period, the IPC-IG implemented 35 projects in the areas of social protection, poverty reduction policies, technological innovation, sustainable development, and inclusive growth.

By disseminating this Activity Report and providing transparent and accurate information on the work developed in 2021, the Centre seeks to account for its work and inform stakeholders, partners, donors, and society in general.

The document comprises three main chapters featuring the projects, activities and products developed around each of the Centre's pillars. We present 17 projects under the knowledge production pillar, eight projects under the knowledge-sharing pillar; and 10 projects under the capacity-strengthening pillar.

Presented in overview tables, they display information about the partners, objectives, outcomes, and the responsible team, accompanied by a snapshot of outputs and tangible results. The last chapter introduces the IPC-IG's staff during the report period.

The IPC-IG and UNICEF LACRO partnered in 2018 to produce a series of knowledge products on social protection in Latin America and the Caribbean (LAC). In 2021, the IPC-IG team finalised two additional Technical Notes related to social protection during COVID-19 (one on Venezuelan

migrants, developed in partnership with WFP, and one on registration and payment Innovations), as well as a study on universal child benefits in LAC. Another study on social protection responses to children on the move in LAC was also finalised (to be published in early 2022).

This project started in 2018. Due to the COVID-19 pandemic, many components within the Sri Lanka and Afghanistan legs of the project were modified. For Sri Lanka, in 2021, a small brief on social protection responses to COVID-19 and a public expenditure rereview were developed. For Afghanistan, the team provided support to the local consultant, MgtWell, tasked with conducting consultations with the government to develop the social protection policy and the governance framework. The IPC-IG team reviewed and helped elaborate questionnaires for key informant

surveys and prepared the draft outlines for the policy and the governance framework. Due to Afghan political crises in August 2021, the advisory and technical support activities were halted. Only the new needs assessment study and the Zakat paper were fully developed. Within the regional component of the project, the study "Social assistance programmes in South Asia: an analysis of socio-economic impacts" was finalised, together with a One Pager series. In November 2021, the project was extended to February 2022, to allow for the publication of the various reports.

The IPC-IG has partnered with UNDP Brazil and the Government of the State of Bahia to support the development of a strategy for the planning and management of the SUAS through the production of 10 studies that will allow for the formulation of the new PEAS and the SUAS Improvement Pact. The Centre delivered all expected studies in 2021. As part of the participatory

methodology adopted, the team organised workshops with partners and collaborators to present and discuss the main findings. As a result, two One Pagers: "SUAS Bahia: challenges and strategies for participation and social control" and "SUAS Bahia: communication challenges and strategies to reach civil society" have been published in both English and Portuguese.

The final reports concerning 1) an analysis of the formative dimensions of learning assessments and institutional evaluations of the judicial schools; and 2) the comparative and descriptive international analysis of labour jurisdiction law systems (Argentina, Brazil, Mexico, Portugal, South Africa, and South Korea) were delivered in December 2021. The team has organized

and hosted five webinars to discuss the studies cases with international and Brazilian labour justice experts. The translation and publication of reports featuring the main findings of the studies are under way, as well as the negotiation for project extension, which will allow for the development of additional research.

In September 2021, the IPC-IG and UNICEF MENARO signed an extension of the previous UN-to-UN agreement to continue providing technical assistance related to social protection in the MENA region. In 2021, the IPC-IG team supported the organisation of the Arab Ministerial Forum, as well as the preparation of a roundtable on young people's transition to work (YPTW) in MENA. In addition,

the team developed a series of four Practitioners' Notes on shock-responsive social protection and an assessment of the social protection responses to COVID-19 in the region (both to be published in early 2022). Finally, the team provided ad-hoc assistance to UNICEF Yemen and the Regional Office and started developing a brief on linking social protection and child protective services.

To better understand the wide set of social protection responses to COVID-19 by governments of developing countries and their potential in the medium term to impact national social protection systems, the IPC-IG started to map and assess social protection measures at the national level in the global South. The research team that had previously supported the "Social protection responses to COVID-19" Task Force developed a tracking matrix or mapping aiming to generate evidence for the systematic analysis of adaptations and innovations of social protection interventions.

The IPC-IG mapping stands out from the other mappings for its rich level of detail and adopting a shock-responsive social protection perspective, allowing researchers, practitioners,

and policymakers in the social protection field to benefit from a repository of experiences and government practices from developing countries worldwide, providing subsidies for evidence-based decision-making for medium- and long-term solutions. The IPC-IG, UNDP Brazil and the *Deutsche Gesellschaft für Internationale Zusammenarbeit* (GIZ) GmbH on behalf of the German Federal Ministry for Economic Cooperation and Development (BMZ), then partnered to develop a user-friendly interface for the matrix to improve the reach of its results. The Online Dashboard was made public in May 2021 after further revision rounds by the research team of the data compiled in the matrix, development of indicators to illustrate findings, as well as storytelling narratives, development of the layout and design of the dashboard, and internal and external peer-review processes.

The UNDP BPPS is providing social protection support to governments and UNDP Country Offices through their Global Policy network. UNDP has included several social protection priorities in their Strategic Plan 2021-2024, and this project between the IPC-IG and the UNDP BBPS Inclusive Growth Team (IG) aims to operationalise some of the social protection objectives at the country and regional levels. In 2021, the IPC-IG finalised the UNDP SP Offer

Implementation Plan, which is the basis for supporting regional and Country Offices with their social protection endeavours. In 2021, the IPC-IG finalised for the UNDP BPPS IG team a 'Next Practices' paper that systematises the social protection innovations implemented in response to the COVID-19 pandemic, which can be leveraged to build more inclusive and sustainable systems in the medium and long term.

In 2021, the IPC-IG delivered a feasibility report for the implementation of a Social Registry to the Government of Burundi. IPC-IG facilitated a validation workshop for the SEP/CNPS and other major social protection stakeholders in Burundi, in which the feasibility report was presented and approved. Based on a remote (online) UN-to-UN Agreement between the IPC-IG and FAO-RLC, the IPC-IG produced three Policy Research Briefs and One Pagers, as well as one webinar with support from FAO RLC and FAO HQ analysing good practices in the social protection response to COVID-19 in rural LAC. The purpose of these outputs was to investigate the experiences of national good practices within the region whose experiences could be used as references to build back better LAC's social protection systems for rural populations.

1. The first PRB and OP focused on how to improve post-COVID-19 rural social protection to promote rural double (social and economic) inclusion and guarantee food security.

- 2. The second PRB and OP focused on how rural social protection can protect and promote employment in rural LAC after the COVID-19 pandemic.
- 3. The third PRB and OP focused on how digitalisation can be used to improve the efficacy and adequacy of rural social protection in LAC after the health crisis.
- 4. Based on the findings of the three PRBs/OPs, the IPC-IG and FAO-RLC jointly organised a webinar with panellists from both organisations, FAO HQ and representatives from Panama, Brazil and the Dominican Republic (case studies from PRBs 1 to 3) to discuss the studies' main findings.

The IPC-IG joined a project with UNICEF Kenya in 2018 to support the country's State Department for Social Protection to review and update its 2012 National Social Protection policy. The objective of the current agreement is to help the government undertake and finalise the new revisions of the Social Protection Policy and develop the Implementation Framework. After a December 2020 workshop, the IPC-IG revised the Social Protection Policy and submitted a revised version. Another workshop took place in August 2021 with selected stakeholders, who made further comments.

These comments were addressed, and the Policy was proofread and laid out by December 2021. In March 2022, as per the request from the government, another revision and a further editing round will take place in a workshop. Other activities related to the project are foreseen in 2022, as the Centre is supposed to support the dissemination and advocacy around the revised Policy within four months after its finalisation; and an Implementation Framework of the Kenya Social Protection Policy must be drafted within nine months from its finalisation.

The aim of this project is to conduct a needs and impact analysis of social protection and basic income in Libya as a response to COVID-19 on private-sector workers and vulnerable groups. The first component of Phase II will consist of a literature review and desk assessment of socio-economic impacts of COVID-19 in Libya. This analysis will seek to synthesise research from different international agencies, the Libyan government, and independent academic and policy research. The second component will consist of a quantitative assessment of COVID-19 impacts in Libya. The IPC-IG will use available survey

data, such as the REACH multi-sectoral needs assessment (MSNA) which focuses on COVID-19 impacts among the Libyan population, and UNDP Libya's 2020 Labour Market Assessment (LMA) by IOM and UNDP, which provides a qualitative assessment of the impact of COVID-19 on Libyan businesses as of July 2020. The IPC-IG has partnered with the FAO Subregional Office for West Africa to develop a study aiming to take stock of the state of social protection schemes for agri-food system workers in the West Africa region. Furthermore, this project will detail selected country cases where good practices are identified through desk review and key informant interviews, as well as create a space for dialogue (through a webinar) between UN agencies, international and

regional organisations, national governments, and civil society to discuss how to enhance social protection for agri-food system workers. In 2021, the IPC-IG team developed the preparatory activities (e.g., elaboration of terms of reference, budget, workplan, internal brainstorming, and preliminary literature review) to kickstart the project. The UN-to-UN agreement between UNDP and FAO was signed in December 2021.



The IPC-IG conducted eight projects under the knowledge-sharing pillar from January to December 2021, promoting and facilitating the exchange of information, learning and collaboration.

To consolidate the knowledge gathered in the projects developed around our three pillars, 108 publications were released in different formats and multiple languages. The IPC-IG publications also serve to share both newly produced and previously existing knowledge

In November 2021, the IPC-IG team, through the social protection.org platform, supported the Regional UN Issue-Based Coalition (IBC) for Social Protection, coordinated by UNICEF and ILO, in collaboration with UN ESCWA, to facilitate the Arab Ministerial Forum 2021. Representatives of the

ministries in charge of social protection of all 20 countries in the region and other invited partners participated in the event. Prior to the Forum, a closed technical meeting had taken place in October, featuring the participation of the highest-level technical staff from the invited Ministries.

Publications

The IPC-IG believes that the free exchange of knowledge inspires people to produce further research and contributes to a more inclusive future. Part of the Centre's mission is to deliver its evidence-based policy research on issues related to development through different publication formats. All new publications are made freely available online through the Centre's website every month, originally released in English. Translated versions are also produced in Arabic, Bahasa (Indonesia), Chinese, German, French, Italian, Portuguese, Spanish, Turkish and Swedish.

The Centre made available a total of 108 publications in 2021, including three new issues of Policy in Focus, 31 One Pagers, 5 Working Papers, 7 Research Reports, 10 Policy Research Briefs, and 11 Joint Publications. It produced 41 translations (23 in Portuguese, 3 in Arabic, 11 in French 4 in Spanish). Since the start of its activities in 2004, IPC-IG publications have been downloaded over 9.9 million times across over 180 countries, as of December 2021.

Policy Research Briefs ppresent concise theoretical and practical analyses of concrete policy options in the broader development field.


One Pagers are extremely popular short-format publications which seek to introduce a wide audience of readers to the core ideas or concepts explored in greater depth in larger works.





"Wealth tax: Perspectives in a post-pandemic world"

Wealth inequality is even greater than income inequality and has increased in recent decades. This occurs in part because personal wealth is much more unequally distributed than income, and many households do not have any (or even negative) wealth. In the absence of capital taxation, wealth concentration tends to increase and self-reinforce, since the top richest can save more, diversity investments, and transfer wealth through untaxed inheritances. This issue of Policy in Focus is dedicated to wealth taxes, presenting deep debates on whether they can be an effective instrument to promote a more inclusive recovery in a post-pandemic world.

"Next Practices-Innovations in the COVID-19 social protection responses and beyond"

The COVID-19 pandemic has necessitated large-scale, rapid responses from governments to ensure that the negative effects of the crisis on people's livelihoods are mitigated. Countries with more well-established social protection systems in place prior to the crisis were able to respond faster, but almost all countries required innovative practices to quickly deliver social protection to those usually excluded from benefits, such as informal-sector workers, refugees and migrants. This report aims to systematise the social protection innovations implemented in response to the COVID-19 crisis, which can be leveraged to build more inclusive and sustainable systems in the medium and long term.





Policy Research Brief No. 75

"Mandatory social distancing measures in Brazil: a comparative analysis of state governments' responses to the first and second waves of the COVID-19 pandemic"

In the absence of a nationwide social distancing policy in Brazil, state governments played a central role in the adoption and enforcement of these measures, with varying degrees of strictness and effectiveness. This Policy Research Brief presents an assessment and comparison between them, to estimate at least three of their potential impacts: i) impacts on the dynamics of the pandemic in a given geographical area; ii) the extent to which they induced behavioural change in the population; and iii) their socioeconomic impacts.


To keep the Centre's activities and production in sync with the latest trends in web design, our website was completely remodelled, and the new version was released in January 2021.

Revamped features include the new Projects section, presenting the Centre's projects since its foundation, as well as related publications and news articles; a better search system for both projects and publications; a Newsroom section; and a better and more intuitive user experience, making the website easier to navigate and to find content. The website is available in both English and Portuguese.

From January to December 2021, visits to the website increased by almost 15 per cent compared to the same period from the previous year. The average monthly number of publication downloads also increased by 13.4 per cent.
